Any business or organization may submit an application for membership and for a certificate of participation. There is no processing fee for the application. The Florida Office of the Attorney General reserves the right to deny participation or recognition.

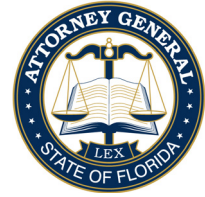
Instructions for Form

- **Applicant Information:** Provide the full legal name of the applicant and its office address. The contact point is the individual to whom any correspondence may be addressed regarding the application or documentation provided.
- **Business/Organization Information:** Completion of this section is not required but optional. However, the information provided may be useful when identifying best practices for combating and preventing human trafficking within certain industries, businesses, or organizations.
- **Execution:** The application must be signed by a person who is authorized to sign on behalf of the applicant.
- **Delivery Instructions:** The completed form may be emailed to CitizenServices@myfloridalegal.com. A certificate of participation will be issued on filing a completed and approved application.
- **Training:** The required human trafficking training is available through the Florida Alliance to End Human Trafficking. The training can be accessed at youcanstopht.com/training.html.
- **Quick-Reference Resources:** Downloadable and printable information is available at youcanstopht.com/how-you-can-help.html. The alert cards and posters should be placed in employee vehicles and common areas.
